PORT ROYAL BOROUGH COUNCIL MEETING

January 9, 2023

The Port Royal Borough Council held their monthly meeting on Monday, January 9, 2023, at 7 pm at 111 East Eighth Street, Port Royal, PA 17082.

Members present were President, Adam Bryner, Vice-President, Brooks Gamble, Council Members, Glenda Leister, Nicholas Walters, John Towsey, Teresa Murphy, Steve Bargo and Mayor, Dylan Cisney.

President of Council, Adam Bryner, brought the meeting to order and led all in the Pledge of Allegiance at approximately 7 pm.

FIRST ON THE AGENDA

Grant Application Updates: The \$401,814 grant request under the PennDOT Multimodal program remains open. Next CFA meeting is January 12th.

A grant for \$489,673 was submitted December 21st to DCED – Covid19 ARPA PA Small Water and Sewer Grant Program. Office has a file copy along with an electronic copy. This grant will cover three areas: 8th & Milford, 4th, and Main Street from 6th to 5th Street.

The Army Corp remains on schedule to complete their report this Spring. The most recent correspondence involved the model predicting flooding on East 5th Street that cannot be supported based on historical observations. Information was provided to support the 2023 COVID Small Water, Sewer Grant regarding 4th Street.

New Pickup Truck is exceeding expectations.

Salt Contract has been met for this year. New Contract has been opened and the decision was made to place the contract at 75 tons again for the coming year.

The bridge will be closed during construction to pedestrian traffic. There will be no agility funds for this winter.

Discussion continued regarding issues of snow removal for the bridge and Market Street during bridge closure. Secretary has been requested to call Rachel at PennDOT State Shed and get written confirmation of the frequency and winter maintenance schedule.

Randy Williamson extended his thanks to John Towsey for his help in addressing the 811 tickets.

Randy Williamson asked the council to consider the idea of using dash cam on the plow truck. Council then discussed they should also consider the other truck and skid steer as well. Mike Tate of GME will be contacted to see if he could potentially ad to his services or make a recommendation.
